Definitions	
Affiliates	Companies related by common ownership or control. They can be financial and nonfinancial companies. Purefy <i>Inc. group of companies are</i> <i>affiliates of each other and are financial services</i> <i>companies that include banks (Citizens Bank),</i> <i>credit unions (PenFed Credit Union), student loan</i> <i>refinancing websites, and other</i> <i>marketplace referral sites.</i>
Non-affiliates	Companies not related by common ownership or control. They can be financial and non-financial companies. <i>Purefy INC. does not share your</i> <i>information with these groups.</i>
Joint marketing	A formal agreement between nonaffiliated financial companies that together market financial products or services to you. <i>Purefy INC.</i> <i>joint marketing partners include our lending</i> <i>partners, financial websites and marketing</i> <i>companies.</i>

Other important information

If you are a California resident, we will not disclose information about you to nonaffiliated third parties except as permitted by applicable California law. To the extent California privacy laws apply to us, we will also limit our sharing of information about you with our affiliates.

If you are a Vermont resident, we will not share information about you, other than transaction and experience information, with our affiliates for any purpose, nor will we share any information about you with our affiliates for marketing purposes.
